

**Midwestxc Racing
2009 Waiver and Release
of Liability Agreement**
THIS IS A CONTRACT - READ CAREFULLY

In consideration for racing with Midwestxc Racing and/or being permitted to complete, officiate, observe, work, or participate in any way in the EVENT(S), or entering for any purpose the RESTRICTED AREA (defined as the racetrack, pit areas or any area requiring special authorization, credentials or permission to enter or any area to which admission by the general public is restricted or prohibited): I HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the promoters, participants, racing associations, track operators, track owners, officials, riders, pit crews, rescue personnel, sponsors, advertisers, owners, and lessees of premises used to conduct the EVENT(S), and each of them, their directors, officers, agents and volunteers, herein referred to as "Releasees," FROM ALL LIABILITY TO ME, my personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFOR ON ACCOUNT OF INJURY TO ME OR MY PROPERTY OR RESULTING IN MY DEATH ARISING OUT OF OR RELATED TO THE EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE. I HEREBY ASSUME FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE TO ME arising out of or related to the EVENT(S), whether caused by the NEGLIGENCE OF RELEASEES or otherwise, and acknowledge that MOTORSPORT RACING IS A DANGEROUS ACTIVITY. I HEREBY AGREE that this Release and Waiver of Liability and Assumption of Risk Agreement (hereafter WAIVER) extends to all acts of negligence by the Releasees, including negligent rescue operations. I AGREE to obey Midwestxc Racing Competition Rules and to respect the authority of officials and personnel at all events. I STIPULATE that all the statistical and personal information I have submitted is true and correct under penalty of perjury. I have read and understand this WAIVER, understand that I have given up substantial rights by signing it, and have done so freely and voluntarily without any assurance or guarantee being made to me and I intend this WAIVER to be a complete and unconditional release of all liability to the greatest extent allowed by law.
